**Insignificant Alteration – Permit**

RE: Application No. 07-0051 in reference to the property and proposed project located:

Approximately 30 feet northwest of Pascoag Main Street, by utility pole nos. 590 and 591, approximately 50 feet northwest of the intersection of Park Place and Pascoag Main Street, Assessor's Plat 175, Lot 44, Burrillville, RI.

Dear Mr. Desnoyers:

Kindly be advised that the Department of Environmental Management's ("DEM") Freshwater Wetlands Program ("Program") has completed its review of your **Request for Preliminary Determination** application and has evaluated the proposed commercial building with an 8 foot wrap around deck as illustrated and detailed on site plans submitted with your application. These site plans were received on February 8, 2007.

Our observations of the subject property, review of the site plans and evaluation of the proposed project reveals that alterations of freshwater wetlands are proposed. However, pursuant to Rule 9.03 of the Rules and Regulations Governing the Administration and Enforcement of the Fresh Water Wetlands Act (Rules), this project may be permitted as an **insignificant alteration** to freshwater wetlands under the following terms and conditions:

Terms and Conditions for Application No: 07-0051

1. This letter is the DEM's permit for this project under the R.I. Fresh Water Wetlands Act, Rhode Island General Laws (RIGL) Section 2-1-18 et seq.
2. This permit is specifically limited to the project, site alterations and limits of disturbance as detailed on the site plan submitted with your application and received by the DEM on February 8, 2007. The property line shall be the limits of all vegetative clearing, surface and subsurface disturbance. A copy of the site plan stamped approved by the DEM is enclosed. Changes or revisions to the project which would alter freshwater wetlands are not authorized without a permit from the DEM.
3. Where the terms and conditions of the permit conflict with the approved site plan, these terms and conditions shall be deemed to supersede the site plan.
4. You must notify this Program in writing immediately prior to the commencement of site alterations and upon completion of the project.

5. A copy of the stamped approved site plan and a copy of this permit must be kept at the site at all times during site preparation, construction, and final stabilization. Copies of this permit and the stamped approved plan must be made available for review by any DEM representative upon request.
6. Within ten (10) days of the receipt of this permit, you must record this permit in the land evidence records of the Town of Burrillville and supply this Program with written documentation obtained from the Town showing this permit was recorded.
7. The effective date of this permit is the date this letter was issued. This permit expires four (4) years from the date of issue.
8. Any material utilized in this project must be clean and free of matter which could pollute any freshwater wetland.
9. Prior to commencement of site alterations, you shall erect or post a sign resistant to the weather and at least twelve (12) inches wide and eighteen (18) inches long, which boldly identifies the initials "DEM" and the application number of this permit. This sign must be maintained at the site in a conspicuous location until such time that the project is complete.
10. Temporary erosion and sediment controls detailed or described on the approved site plan shall be properly installed at the site prior to or commensurate with site alterations. Such controls shall be properly maintained, replaced, supplemented, or modified as necessary throughout the life of this project to minimize soil erosion and to prevent sediment from being deposited in any wetlands not subject to disturbance under this permit.
11. All disturbed and exposed soils must be permanently stabilized with some form of native vegetation such as a conservation grass seed mix that tolerates shady conditions (See enclosed Wetlands Fact Sheet #4).
12. All plantings of shrubs, trees or other forms of vegetation as shown or detailed on the approved plan, or detailed in this permit, must be installed as soon as possible after completion of final grading; weather and season permitting.
13. Upon permanent stabilization of all disturbed soils, temporary erosion and/or sediment controls consisting of silt fence must be removed.
14. This Program has made specific revisions to the approved site plan. These revisions are clearly marked in red on the approved plan. This project must take place in compliance with these revisions. Specifically, a) Erosion controls (see enclosed Wetlands Fact Sheet #4) shall consist of either a continuous line of staked haybales or silt fence and must be installed in the designated area and, b) The property line shall be the limit of all vegetative clearing and surface or subsurface disturbance (LOD).

Please note that this Department has not verified the wetland edges that are illustrated on the approved site plan, as part of this application. Therefore, you must strictly adhere to the limit of disturbance depicted on the approved site plan.

This permit is valid for the original applicant only and is not transferable to another person unless the new owner completes and submits an **Application for Permit Transfer** in accordance with Rule 9.08.


You are required to comply with the terms and conditions of this permit and to carry out this project in compliance with the Rules at all times. Failure to do so may result in an enforcement action by this Department.
