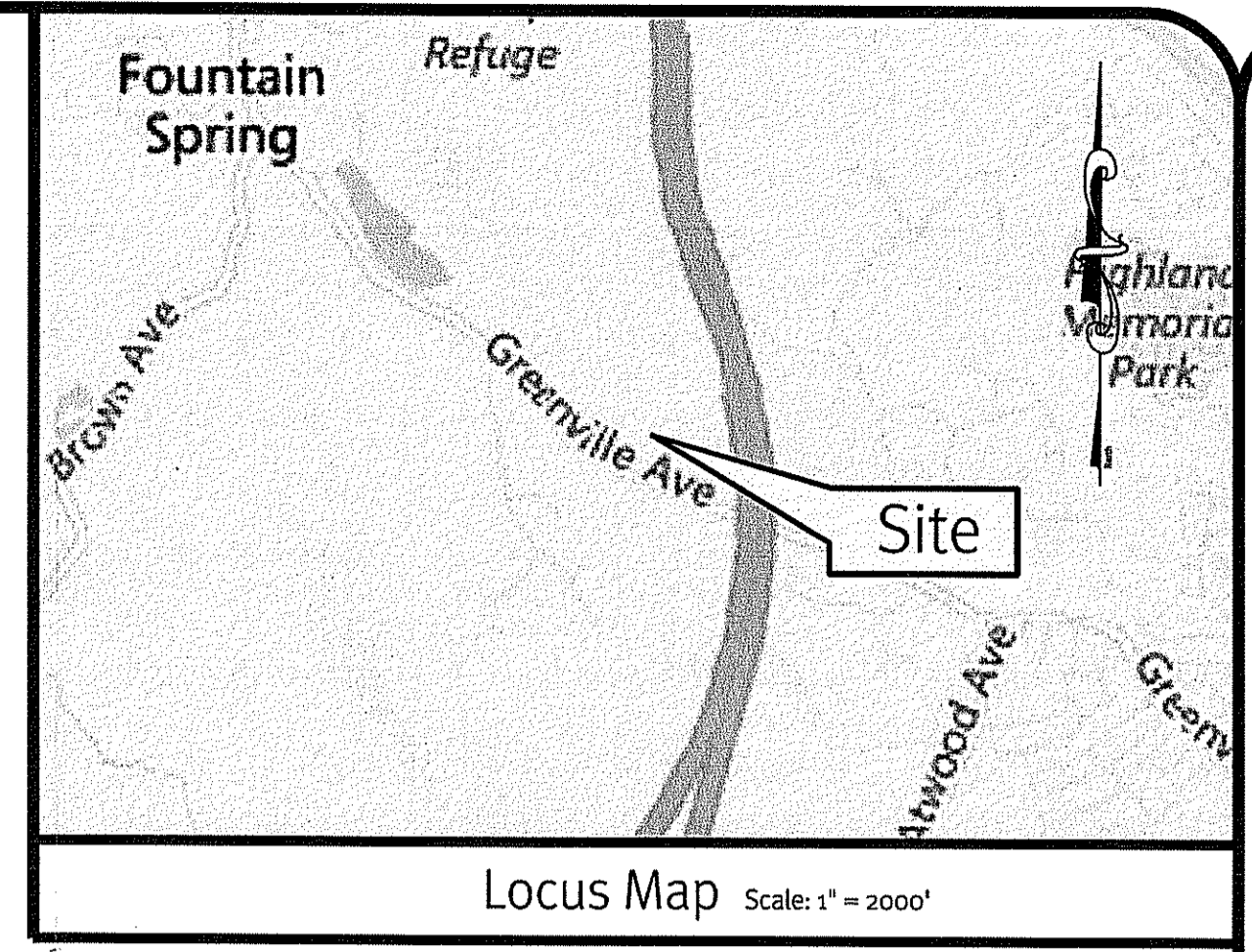

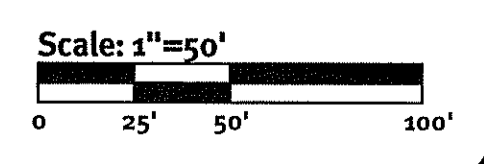
General Notes:
